SCENIC ROAD PUBLIC HEARING APPLICATION SUBMISSION REQUIREMENTS

Submission Requirements: Scenic Road Applications are evaluated in accordance with Wrentham General Bylaw Chapter 346 (https://ecode360.com/WR4159).

Pre-submission Review – Applicants wishing to discuss or review their application in draft format or prior to formal submission can contact the office to discuss their options.

Submission: All application materials must be presented in a complete packet at the time of submission for staff to review and schedule a hearing.

Required Submission Materials:

- **1. Application for a Hearing Under the Scenic Road Bylaw.** Including ALL required signatures, One (1) original and two (2) copies
- 2. Tax Collector sign off
- 3. Project Description / Narrative
- **4.** Plan and Photographs A plan of proposed work including photographs of proposed work area.
- **5. Abutter Notification Materials** Certified Abutters List prepared by the Wrentham Assessor's office within 300' of the locus property, envelops & stamps.
- **6.** Fees includes all applicable fees outlined on the Fee Schedule.
- 7. Additional Materials as Needed / Required to Support the Application.

APPLICATION FOR A HEARING UNDER THE SCENIC ROAD BYLAW

The Wrentham Scenic Road Bylaw (Town of Wrentham General Bylaw, Chapter 346) provides that any repair, maintenance, reconstruction or paving work done with respect to any road designated as a Scenic Road shall not involve or include the cutting or removal of trees or tearing down or destruction of stone walls, or portions thereof, except with prior written consent of the Planning Board after a public hearing.
