Sealed bids will be received at the Offices of the Town of Wrentham, Town Hall, 79 South Street, Wrentham, Massachusetts, 02093 up to 11:00 A.M. local time, **January 11, 2023** which time and place, they will be publicly opened and read.

The bids will be for all labor, materials, equipment, tools, appliances etc. necessary for construction of a paved parking lot with the improvements specified herein at the former Center School Site, 5 Dedham Street IN THE TOWN OF WRENTHAM, MA.

Specifications may be obtained after **December 13, 2022** at the Wrentham Town Hall Town Administrator's Office, 79 South Street, Wrentham, Massachusetts, 02093.

Each bid proposal must be secured by an accompanying deposit of five percent (5%) of the total bid amount and submitted in a sealed envelope clearly marked, "Proposal for PAVING AND IMPROVEMENTS TO FORMER CENTER SCHOOL SITE IN THE TOWN OF WRENTHAM". The deposit shall be in the form of a Bid Bond, Certified Check, Cashier's or Treasurer's Check, made payable to the Town of Wrentham, or cash.

The successful bidder must furnish a Payment Bond and a Performance Bond of an amount equal to One Hundred (100%) Percent of the total Contract Price, issued by a Surety Company, satisfactory to the Town of Wrentham.

Attention of the Bidders is particularly called to the requirements of the conditions of employment to be observed and the prevailing wage rates to be paid on this project, as determined by the State Department of Labor Division of Occupational Safety. Bidders must be prequalified and certified by the Massachusetts Highway Department to perform this work.

Note: Bidders must also comply with Certification of Compliance G.L. C. 30 & 39S Public Construction More Than \$10,000,00.

The Town of Wrentham, acting through its Town Administrator, reserves the right to waive any informality in, to reject any or all bids or to accept the one which appears in the best interest of the Town of Wrentham.
